Dear Minister Bennett,

On January 14-15, 2016, the first-ever Pan-Territorial Assessment and Regulatory Board Forum (Forum) was held in Yellowknife, Northwest Territories, with the support of the Canadian Northern Economic Development Agency (CanNor). The purpose of the Forum was to enable representatives from regulatory and environmental assessment boards based in Nunavut, the Northwest Territories, and Yukon ("the Boards") to share best practices, explore common challenges, and discuss potential solutions. The Forum provided an opportunity to build relationships between organizations that will allow for ongoing support, information sharing, and development of consistent environmental assessment and regulatory approaches across the North, as appropriate.

The specific objectives of the Forum were to:

- Discuss and understand the key challenges facing northern regulatory and environmental assessment boards;
- o To learn from individual successes and exchange best practices with respect to common challenges;
- o Provide an opportunity for building relationships between the Boards that will allow for ongoing support and information sharing; and
- o Identify possible opportunities for developing more consistent approaches to common processes as appropriate.

This Forum built on the varied and substantive work undertaken by the Boards in recent years, individually and through collaborative initiatives in each territory, to make regulatory

and environmental assessment processes more effective, transparent, and consistent, where possible under the various pertinent Land Claim Agreements and legislation. We encourage the new government to work with the Boards to continue to make meaningful and useful enhancements to resource management systems, by building on and supporting the work the Boards have already been doing.

Following productive discussions at the Forum, representatives from regulatory and environmental assessment boards across the north identified several key areas to prioritize for follow-up work and discussion at future meetings. The Boards agree that one of the top priorities is to ensure that northern communities and organizations have the capacity to participate effectively in board proceedings, as their active engagement leads to informed decision-making by the Boards. **Toward that end, we resolved to voice our support for government's efforts in seeking and facilitating participation by stakeholders and aboriginal organizations in resource management decision-making processes.**

A report of the inaugural meeting of the Pan-Territorial Regulatory Board Forum is enclosed and will be made publicly available online. A second Forum is planned for Fall 2016 in Whitehorse, Yukon. This next Forum will provide an opportunity for the Boards to delve deeper into the common issues or challenges identified and advance potential solutions while furthering open communication and cooperation across the territories. We welcome the continued support of CanNor and the federal government for these collaborative initiatives that support and encourage effectiveness, transparency and consistency, and we look forward to continuing to work together.
