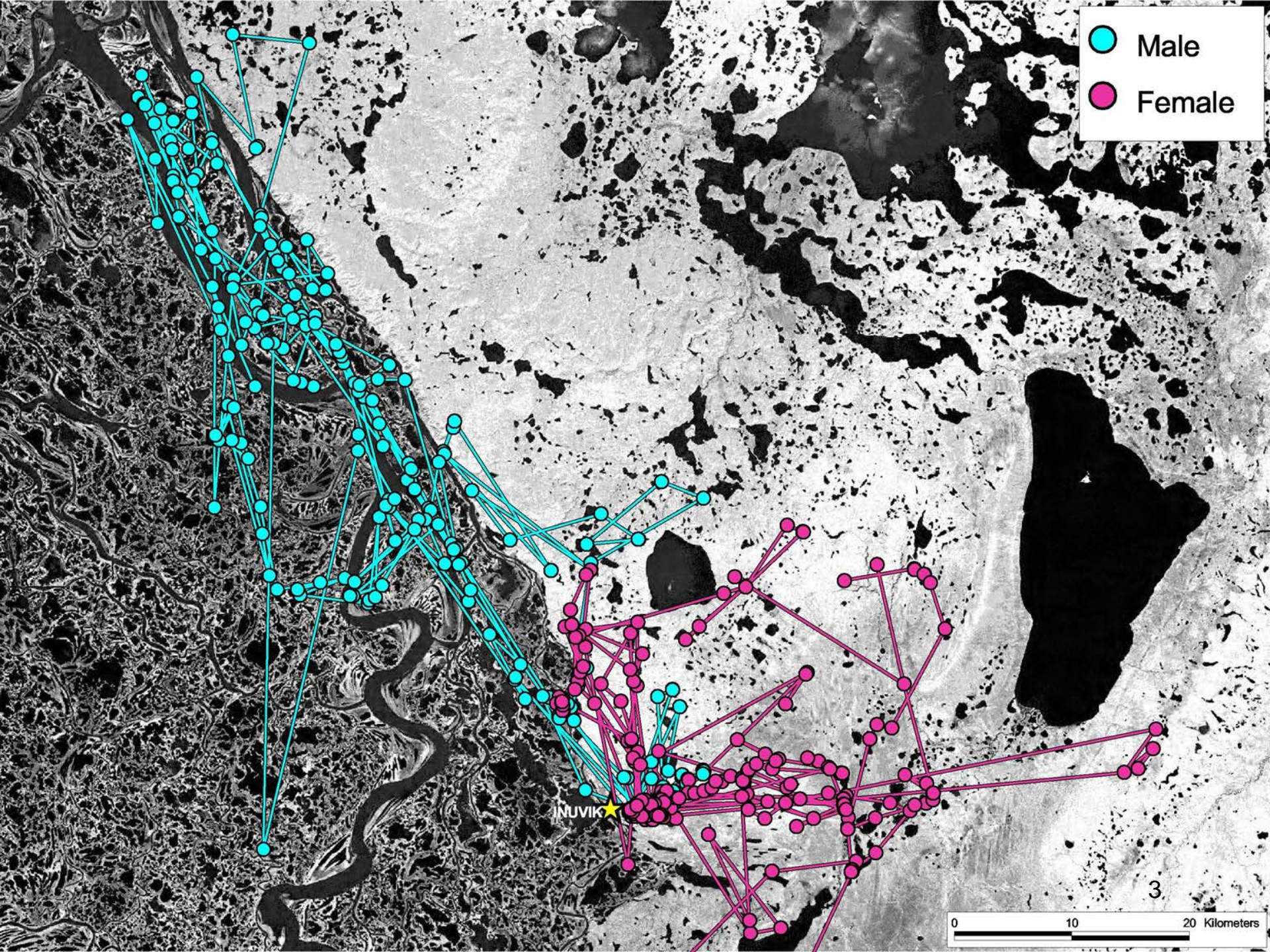

Inuvik Region occurrence reports
228 - of those 191 are from Inuvik

Water Licence

GRRB Recommendation: investigate bear deterrent methods and other alternatives to killing bears at the Inuvik Landfill.

TOI: Bear deterrence from solid waste sites and from townsites generally is a well-known and seemingly somewhat intractable problem, in communities spanning the spectrum from Vancouver to Inuvik and beyond. Inuvik would be very pleased to host a GNWT-funded research project. The results would have application at all northern communities, and quite likely throughout Canada.



Bears and Humans

- Many instances where reducing access to landfills has been successfully implemented
- Requires on-going efforts and a plan
- ENR opinion that there is no need for a GNWT funded research project
- Many communities are implementing Bear Smart or Bear Wise programs



Fencing The Landfill

Multiple purposes

- Keep garbage contained
 - Prevent garbage from blowing into adjacent water or creating unsightly lands
 - Inspection reports for a number of Inuvik region landfills recommending installation of fences for this purpose
- Keep wildlife out
- Keep humans out – safety issue



Examples

- Fencing of land fills
- Use of bear deterrents
- Ongoing maintenance required
- Community awareness programs



Bear Smart Waste Management could include a variety of options

- **Move the landfill sites further from town**
- **Cover or remove domestic garbage daily**
- **Install permanent electric fencing**
- **Implement Bear smart by-laws in community**
- **Use bear proof garbage containers**
- **Implement a continuing education program on bear awareness**
- **Restricting curb-side placement until collection day**

Bear Smart Program

- Needs to be collaborative and multi-pronged
- If dump is fenced, in short term more bears will come into town
- Removal of habituated food-conditioned bears likely required
- Town needs to be ready
- ENR needs to be ready
- Discussions with WMBs need to happen



Moving Forward - ENR

- ENR agrees with GRRB that there is a problem with bears in the Inuvik Landfill
- Landfills need to be managed to reduce bear access to attractants and keep garbage contained
- ENR is willing to work with the TOI and co-management partners to develop a plan of action moving forward on reducing bear attractants including access to the landfill

Potential Options under Water Licence
